Golden Ears Ride Rules

1. All AERC and PNER Rules apply.
2. The veterinarian's opinion will be final in matters concerning the condition of the horse. Horses disqualified by the vets must not continue on.
3. Shoes recommended. Easy boots will be accepted.
4. Rider consumption of alcohol during the ride is prohibited.
5. All horses must be presented to ALL vet checks, before, during and after the ride. **THERE WILL BE NO EXCEPTIONS.**
6. All horses must pass post-ride criteria for completion.
7. Ride management or veterinarians will excuse unmanageable or unruly horses.
8. Stallions must be ridden by person's 18 years and older.
9. Horses entered in this event must be at least 60 months old at the time of the ride. This applies to the 50 mile ride only. Horses in the 24 mile ride must be at least 48 months old.
10. The same horse and rider must follow the prescribed course, do multiple loops in the correct order, pass all check points on the same marked trail together, and finish within the prescribed time.
11. No horse may be paced or prompted by an unentered, withdrawn or otherwise unauthorized horse, vehicle or person other than the entrant.
12. The fastest horse to finish and meet the completion criteria of "Fit to Continue including Sound at the Trot" is the winner. This applies to the 50 mile ride only. The 24 mile ride time is not finished until the heart rate meets criteria.
13. An adult sponsor must accompany riders under 16 years of age as of December 1, 2000 during the entire ride. They must be within 1 minute of the sponsor at all times.
14. Protective headgear with harness will be mandatory for all junior riders and is strongly recommended for all riders.
15. Drugs of any kind are prohibited in horses participated in AERC sanctioned endurance rides. AERC Rule #13.
16. Abuse of horse; harassment of ride personnel, other riders or crew; removing or altering trail markers or cheating will not be tolerated.
17. The horse may not have received or required medical treatment by veterinarian or layman prior to final veterinarian examination.
18. Dogs welcome if under control and owners clean up after them. Keep them out of vet and eating areas.

I agree I will not hold ride management, ERABC, AERC or PNER or their directors responsible for any accident or injury.
